#### Part A: Pupil premium strategy plan

#### Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across the curriculum, particularly in English and Maths.

The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers. We will consider the challenges faced by vulnerable pupils, including those who have a social worker, or English as an Additional Language as well as travellers, young carers, asylum seekers and refugees and those with Special Educational Needs and Disabilities. This statement is intended to support these vulnerable groups, regardless or whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they are set
- ensure disadvantaged pupils have the scaffolding needed to enable them to complete work that they are set
- ensure that disadvantaged pupils have high levels of literacy and numeracy that feed into the rest of the curriculum
- ensure that children understand the progress they have made and what their next steps are to improve.

## **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	The maths attainment of disadvantaged pupils is generally lower than that of their peers. Assessments on entry to year 7 in the last 2 years indicate that between 37-74% of our disadvantaged pupils arrive below age-related expectations compared to 31-34% of their peers. Subsequent external assessment (2019) shows that this gap narrowed to 25% during pupils' time at our school with 32% of PP pupils not making expected progress compared to 7% of non PP pupils.
2	Assessments, observations and discussion with KS3 pupils indicate that disadvantaged pupils generally have lower levels of reading comprehension than peers. This impacts their progress in all subjects.
	On entry to year 7 in the last 3 years, between 45-51% of our disadvantaged pupils arrive below age-related expectations compared to 16-19% of their peers. This gap narrows to 14% during pupils' time at our school with 23% of pupils not making expected progress in 2019 compared with 9% of non PP children.
3	Our assessments, observations and discussions with pupils and families suggest that the education and wellbeing of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are backed up by several national studies.
	This has resulted in significant knowledge gaps resulting in pupils falling further behind age-related expectations, especially in maths.
4	Our observations suggest many lower attaining disadvantaged pupils lack metacognitive / self-regulation strategies when faced with challenging tasks, notably in their monitoring and evaluation of their answers. This is indicated across the curriculum including within Maths and English.
5	Our assessments (including wellbeing survey), observations and discussions with pupils and families have identified social and emotional issues for many pupils, such as anxiety, depression (diagnosed by medical professionals) and low self-esteem. This is partly driven by concern about catching up lost learning and exams/future prospects, and the lack of enrichment opportunities due to the pandemic. These challenges particularly affect disadvantaged pupils, including their attainment.  During the pandemic, teacher referrals for support markedly increased.
	56 pupils (16 of whom are disadvantaged) currently require additional support with social and emotional needs. All are currently receiving individual interventions.

6	Our attendance data over the last 3 years indicates that attendance among disadvantaged pupils has been between 3 - 11% lower than for non-disadvantaged pupils.
	4 - 7% of disadvantaged pupils have been 'persistently absent' compared during that period (though this is lower than their peers with 7-12%). Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.

# Part B: Review of outcomes in the previous academic year

#### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

**Teaching:** Initial in school analysis showed that the progress of PP children compared to all children was -0.48. This is a slight increase on 2019 when the gap was -0.46. The gap was narrowest in the English Baccalaureate with a -0.38 gap. However, progress has been made in Maths, English Language, Science, Art and Dance.

*Wider participation:* All year 11 PP children saw an independent careers advisor and received a hyperlinked action plan. Attendance initiatives and pastoral support resulted an attendance above national average for 2021-22 with overall attendance of 92.15% (though it was not 4%). The gap between PP and non PP children was reduced to 7.77% (85.98% PP compared to 93.75% for non-pp children). All Year 10 and 11 children have had careers interviews and were overwhelmingly positive with their feedback. 33 of the 46 PP children identified on the build-up programme made sufficient improvement to be taken off this programme.

**Targeted academic support**: Small group intervention in English saw improvements in both Year 7 and 8 (65% improvement in Year 7 and 67% improvement in Year 8). Likewise, small group intervention in Maths also saw improvements in both Year 7 and 8 (82% improvement in Year 7 and 81% improvement in Year 8). Sports Studies and Health and Social care and Travel and Tourism alternative provision courses all achieved high residual grades than the main provision of MFL.
