



Dog in School Risk Assessment

The value of having an animal in school is recognised as having a positive impact on people's well-being. Studies have shown that the presence of companion animals can lower rates of anxiety creating calmer states of mind. This applies to staff as well as to children.

Brac is five years old. He is a Welsh Terrier, known for their love of all people and a breed that has a coat which creates very little dander. He is owned by our Assistant Headteacher and SENCO Mrs Stokes. He has been coming to Reigate School since 2021. **Brac currently comes into school two days a week. He is now a trained and qualified PAT (Pets as Therapy) dog. He goes to tutor times, meets individual children or groups of children and is a presence around school with Mrs Stokes.**

It is accepted that interacting with animals is not appropriate for all staff and children but for some it has the potential to provide many positive benefits.

The risk assessment below is a working document and will be checked termly by key staff and annually (or more regularly where appropriate) by the governing body.

Animal Welfare	Negative behaviour caused by stress, bites or scratches	The dog, staff and children	<p>Ensure Brac has time away from the children in his crate undisturbed. The crate is the right size for him to be happy and safe.</p> <p>Ensure Brac only interacts with the children in short bursts.</p> <p>Ensure Brac is not in school full time.</p>		N/A
